As you can see from the stats below the 3<sup>rd</sup> Quarter for the police department started off with a bang, because even though most of the quarter the department was operating in pandemic protocol most of the numbers below still show increases.

The Station Project – The shingles for the replacement roof have been ordered currently in waiting mode for a window of good weather to start the project. The new generator is in, waiting on contractor to start project. The new carport has been ordered and project will start as soon as it is delivered. HVAC system and flooring issues are still being discussed.

We finally took delivery of the new Dodge SUV and A9 has been taken out of service.

On April 13<sup>th</sup>, we conducted interviews to fill vacancies within our per diem officer and dispatcher ranks and anticipate bringing on three (3) new per diem officers and two (2) new per diem dispatchers.

During this quarter, Emergency Management was involved in the following;

- Assisted Laurie Wiita with her Region 2 Emergency Preparedness Drill held at the Middle School, by supplying her with 2 CERT members.
- Turned in Emergency Management's Annual Report for FY2019.
- Had applied for and was awarded, the FY2019EMPG grant \$2,900. Spending on this grant will begin July 1, 2020.
- Participated in BOH's Emergency Dispensing Drill, where participants had to log into WebEOC to participate.
- In the beginning of March, COVID-19 began to escalate, which was the beginning of many hours of conference calls and webinars. On March 16<sup>th</sup> the Town declared a State of Emergency. The ICS structure was put in place, daily conference calls were required to keep ICS staff informed, and I was assigned to the Logistics Chief position. On 3/20, I left Florida to return to Templeton to better handle my responsibilities for this emergency, arriving on 3/22. The EOC has been open Monday through Friday, 7AM to 5PM, since.
- The Fire Department had need for PPE supplies that they could not order through normal procurement methods, so I ordered their needed supplies through MEMA, using WebEOC. Although we have had some issues with the items sent, for the most part, MEMA has been able to get the supplies we requested. I picked up supplies from their warehouse in Marlborough on 1 occasion and the rest has been delivered by the National Guard.
- MEMA requested reporting of First Responder Workforce in every community. This is done through WebEOC and is updated when either Chief calls with changes to their staffing.
- Called MEMA concerning reimbursements for the last 3 grants, as reimbursements have not hit the Town's accounts. Still waiting for the information on this. All MEMA staff have been reassigned for COVID-19 emergency response activities.
- CERT activities have been few due to the time of year. Two or three of the CERT members have been working on reorganizing the EOC. They have done a fantastic job.
