2nd Quarter Report FY21

The 2nd Quarter of FY21 started off with some sense normalcy only to see COVID-19 cases escalate. However, the men and women of the department continue to do their jobs to the best of their abilities. We have had our share of COVID-19 related issues and were able to come through these issues to still provide a quality service to our community.

The Station Project – The Sally port project was completed providing an area capable of sheltering four units from the weather. The consultant for the third-party HVAC vendors came to the station for their walk through and we await their findings to move forward with the HVAC/humidity issues. Some minor projects still need to be completed such as front landscaping, department signage and flagpole these will be addressed hopefully soon.

As part of the department's capital planning requests we finally took delivery of the new cruiser and it has been added to the fleet. The Town has finally received some viable quotes for the new ACO vehicle, and the hope is that we will see progress on those in short order. Also, we heard from the Commonwealth and we hope to see some movement on the completion of the set-up of our Live Scan fingerprint scanner and the installation of eCitations in all the frontline units.

Lastly, the department has one new per diem dispatcher who is now fully trained and capable of covering shifts. The other two per diem dispatchers are both working towards being able to cover shifts and should be able to soon. Again, department is still down one (1) full time officer from the financial difficulties from 2014 and hope is to fill that position sometime soon.


