Article 1 **Passed Over**

Article 2 To see if the Town will vote to Transfer the sum of Fifteen Thousand, Eight Hundred Twenty-Four Dollars (\$15,824.00) from the Interest on Temporary Borrowing, Chapter 90 Account and Six Thousand Dollars (\$6,000.00) from the Interest on Tax Anticipation Note Account to the Group Insurance Account; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer the sum of Fifteen Thousand, Eight Hundred Twenty-Four Dollars (\$15,824.00) from the Interest on Temporary Borrowing, Chapter 90 Account and Six Thousand Dollars (\$6,000.00) from the Interest on Tax Anticipation Note Account, to the Group Insurance Account.
