## **GREETINGS**:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the several precincts of the Town of Templeton, County of Worcester, qualified to vote in elections and town affairs to meet in the Narragansett Regional Middle School in said Templeton on Tuesday, August 5, 2003, at 7:00 o'clock P.M. then and there to act on the following articles:

Article 1. To see if the Town will vote to raise and appropriate, appropriate from available funds, or otherwise provide a sum of money to pay town charges for municipal operational expenses for Fiscal Year 2004, and thereby approve the town charges as requested, provided that this additional appropriation be contingent upon the approval of a levy limit question under the General Laws Chapter 59, Section 21C(g), or take any other action relative thereto.

On a motion duly made and seconded the town voted to raise and appropriate, appropriate from available funds, or otherwise provide the sum of Three Million, Five Hundred and Ninety Eight Thousand and Three Hundred and Forty Two Dollars (\$3,598,342) for the Town of Templeton Town Charges for municipal operating expenses for Fiscal Year 2004. Also to pass each departmental budget as the bottom line and not divide departmental budgets into office expense and salary expense, or take any other action relative thereto.

Article 3 To see if the Town will vote to appropriate from available funds a sum of money to the Stabilization Account, or to take any other vote or votes in relation thereto.

On a motion duly made and seconded the Town voted to appropriate the sum of Twenty-Seven Thousand, Four Hundred Sixty Eight Dollars (\$27,468) from the Stabilization Account for the Town Charges.
