To either of the Constable of the Town of Templeton is said County:

**GREETINGS:**

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the precincts of the Town of Templeton, County of Worcester, qualified to vote in elections and town affairs to meet at the Narragansett Regional Middle School, 460 Baldwinville Road in said Templeton on Tuesday, December 27, 2005 at 7:00 p.m. then and there to act on the following articles:

Article 1. To see if the Town will vote to appropriate from available funds in the treasury a sum of money to be used by the Board of Assessors in fixing the tax rate to meet appropriations made for the fiscal year ending June 30, 2006, or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to appropriate from Free Cash in the treasury the sum of Five Hundred Eighty-two Thousand, Four Hundred Twenty-one Dollars (**\$582,421.00**) to be used by the Board of Assessors in fixing the tax rate to meet appropriations made of fiscal year ending June 30, 2006.
