3rd Quarter Report

The 3rd Quarter brought more of the same for the police department. The weather caused delays with certain aspects of the building construction, which has resulted with the move in date being pushed back to sometime in late May of early June.

Officer Mardirosian graduated from the Western Mass Police Academy on April 12th and started his first shift back on April 16th.

The department has been experiencing higher than normal mechanical issues with the cruiser fleet, which has prompted a serious conversation into switching from Ford to another manufacturer.

The department has a plan in place to move the existing radio antenna at the ladder hill cell tower to the top of the tower with the expectation that it will improve radio communications and help reduce interference.

All part-time officers are in the process of completing their required 40 hours of mandatory in-service training as required by the Municipal Police Training Council.
