3rd Quarter Report FY22

We experienced a slight COVID surge from another variant throughout the State and we had a few related issues within the department, but mostly made it through without any serious incidents. The weather played tricks on us from day to day with one day being almost 70 degrees and the next being in the teens. The end of the quarter brought spring and a moderate up tick in alcohol related incidents.

The Station Project – The HVAC issues are still unsolved, but an engineer is working on a plan, which will address the many areas of need. Once the HVAC has been addressed the next step will be to contact a flooring specialist and have the upstairs floor issues resolved. Finally, by the end of this fiscal year the hope is that we will have a new sign and flagpole installed at the station to close-out the project.

There has been no movement with regards to the new ACO truck or police vehicle. Last update on both, the ACO truck had a built date of 1/31/22 with no delivery date and the police vehicle didn't even have a built date listed. The hope is that something changes soon, because the current ACO truck is barely operational, and we do not want to waste funds repairing a vehicle that is not worth repairing.

As for the projects mentioned at during the FY22 2nd quarter report, the BWCs have been ordered with an expected delivery date of August 2022. As for the Drone Unit it is in the final stages of implementation and the department is seeking a Homeland Security grant to obtain another drone. We feel that both projects will be a huge asset to the department and community.

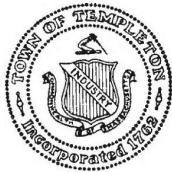

The 3rd quarter had a total of 3341 emergency calls and 63 residential and commercial inspections. 4" and 2 ½' hose from capital has arrived and is in process of being placed in service. The utility truck being purchased with State ARPA funds has been ordered. It should be in service by the end of the fiscal year. Rescue 1 our older ambulance has been in and out of repair for rear end issues with the air ride system, currently it is back and in service. Forestry 2 our 1978 pickup truck has had over five thousand dollars' worth of repairs completed to keep it in service.
