

<u>Notice</u>: The Templeton Senior Community Center is hosting a vaccine clinic on Wednesday, June 22, 2022, from 12:00pm - 3:00pm.

Shingles vaccines will be available for ages 50 and up, and pneumonia vaccines for ages 65 and up. Both vaccines require registration by calling (978) 602-2356, Monday - Saturday 10:00am - 6:00pm.

Covid-19 vaccines (Pfizer, Moderna, and J&J) are available for ages 5 and up. Walk-ins welcomed, though registration is encouraged.



Business Meeting: (This is where we provide basic information or expand upon memorandum enclosed in your packet).

Weekly: Attended meeting with the Massachusetts Department of Fish & Game about future improvements to the area around the River's Edge Conservation Area. We will be meeting with a representative from the state at the site and nearby areas to discuss potential river access. Attended meeting with Representative Zlotnik concerning opioid settlement agreement funds. Work on Collective Bargaining continues.

Attended a meeting at Scout Hall with our DPW Director and an Inspector for testing and expect a report regarding future site work. Met with the Environmental Protection Agency (EPA) about

the properties on Holman Street. We submitted a Brownfields Targeted Assessment Application Form to the EPA. Met with the Tighe & Bond regarding the project on Main Street Bridge and expecting to receive the proposal that will get the Town with the Main Street project through design and all the way to the bidding phase. Working continues with collective bargaining. Responded to public records. Held our opening for insurance proposals on June 2nd. Opened the bids for the Insurance proposal, with Berry Insurance being the apparent lowest bidder.

Administration & Finance

Town Accountant: Nothing to report.

Treasurer/Collector: Very busy for a short week. An excise commitment and the quarterly sewer bills were due this week.

The RMV released the next excise commitment. The bills were prepared and will be mailed Monday.

Warrant processed.

Assessor: Attended Board of Selectmen meeting last week. With the Monday holiday and Tuesday off, short week in the office. Wednesday was spent "catching up". Much time went into compiling information for a records request on Holman Street properties. Thursday attended a webinar (1st one of two being offered) from Vadar, to get ready to process the preliminary tax bills for the 1st and 2nd quarters, which will be mailed out by month end.

Town Clerk: Nothing to report this week.

Public Works

Highway: Continued to deal with beavers on Royalston Road and Stone Bridge Road. Watering at River's Edge Conservation Area. Assist Buildings and Grounds with getting ready for Memorial Day. Pot hole patching Baptist Common Road, and Barre Road. Worked on putting mower on trackless and worked around shop. Removed a tree on North Main Street by Depot Road. Cleaned up from tree that came down in the past on Rice Road.

Building and Grounds: Finished up mowing and weed whacking at Greenlawn Cemetery and Pine Grove Cemetery. Put out Fireman flags in multiple locations. Emptied trash at Gilman Waite, Greenlawn Cemetery, and Pine Grove Cemetery. Mowed and weed whacked Baldwinville Center, Templeton Center, Cottage Lane, Otter River, and Baptist Common Cemetery. Filled stump holes at Greenlawn Cemetery and topped with loam and grass seed. Emptied cardboard at the Senior Center. Installed flat marker. Fixed sunken marker. Sharpened mower blades and cleaned equipment. Went to Nursery to find plantings to go around the new cemetery signs. Started to map out new section at Greenlawn.

ZBA: Nothing to report at this time.

Building Department: Five Building Permits were received and processed this week, including: 1 roof, 1 above-ground pool, 1 replacement windows, 1 interior renovation and 1 residential addition. Seven Electrical Permits were issued, including: 1 Commercial alarm system, 1 hot tub service, 1 Residential service upgrade, and 4 for new single-family homes on King Phillip Trail. One Plumbing Permit was issued for new single-family home on Fourth Street. Provided information to callers interested in properties for sale in Templeton, inquiries about rumored developments, and refuse disposal options.

Agricultural Commission: Please consider a hiatus from feeding wild birds due to the potential spread of Avian Flu. If you have any food birds (including eggs), please keep them away from wild birds and be sure to cook meat and eggs to an internal temperature of 165°

Community Services

Director/Library: Circulation remains steady. We're preparing summer reading incentives for our young patrons. I posted the COA agenda. I worked with Cindy, Cultural Council and Food Pantry Director to ensure excess trust funds are expended. Farmers' Market continues to grow.

Senior Services: The Center was open on Wednesday for the first time in months. Activity suggestions are welcome to fill this additional open day at the Center. 93 activities were attended by 69 different people. Transportation and meals on wheels continued. The Center provided 35 rides during this period (Wednesday-Wednesday).

Templeton Community TV: Week ending June 3, 2022 – We recorded the Memorial Day Parade and Ceremony. A video program should be available shortly. Work continued on other

productions. We are uploading content to the Montachusett.TV website and testing it out. We are aiming for a June release. The first round of videos for the Wachusett Business Incubator (WBi) sponsorship have been approved by the sponsor and will be made available soon.
