Town Accountant: Nothing to report.

Treasurer/Collector: Warrant and payroll processed. Worked on tax taking advertisement. Catching up after getting back from school.

Assessor: Busy catching up on work after being out. Apportioned 4 Title V loans into the billing system and added an additional unapportion Title V loan. Sales analysis for FY23 was approved by the state. Sales from 2021 were used in this analysis. Properties and Land sales continue to sell way above property assessed values, therefore, increasing values <u>substantially</u> for all property owners in town. Additional paperwork has been submitted to the DOR for approval, all part of moving forward in the tax rate setting process. Reminder to residents to apply for their statutory exemptions. These need to be submitted yearly. If you are not sure if you are eligible, please stop by the office to inquire about the guidelines and requirements.

Rich Curtis and Don Morin attended a 'MASSACHUSETTS EMERGENCY MANAGEMENT DIRECTOR ORIENTATION PROGRAM' on Wednesday the 17th. This program was a required course for a new EMD certification. Met with TA Thursday AM to have Peter Laitinen appointed to a vacant Deputy EMD position. Met with MEMA Area Coordinator concerning LEPC vs. REPC for Templeton.

Director: Prepared fourth quarter report and presented at the Select Board meeting of 8/10. Templeton Municipal Water has issued a notice for residents and businesses using municipal water, to limit outdoor use to the hours between 5 p.m. and 9:00 a.m., including the use of automated irrigation systems and sprinklers; flower and vegetable gardens with drip irrigation and watering cans are permitted, for tips on how to conserve water please go to Indoor Water Conservation | Mass.gov, and Outdoor Water Conservation | Mass.gov.

Communicable Diseases: COVID, at last count Templeton had 9 positive cases and an incident rate of 7.9 for the past two weeks. If you take an at home test and test positive, please call 978-602-2356. We still have home COVID-19 test kits available in the town hall offices. Monkeypox – no reportable cases in this area at this time. Frequent handwashing is still your best defense on all levels.

Level 3 Critical Drought. Residents are asked to please try to conserve water.
