



REQUEST FOR WRITTEN QUOTATIONS Town of Templeton, MA

Town Hall Offices Glass & Aluminum Supply and Installation

The Town of Templeton is seeking written quotations for the supply of materials and labor required to install glass safety guards, channel and supports at the Town Hall offices, 160 Patriots Road, East Templeton MA. Prevailing Wage Rates apply.

Written Quotations with scope of work statements shall be submitted to the Select Board's Office, 160 Patriots Rd, Rm. 6, P.O. Box 620, Templeton MA 01438 or emailed to hyoung@templetonma.gov no later than **Thursday, December 2, 2021, at 1:00 p.m.** at which time they shall be publicly opened and read.

The Town reserves the right to accept or reject any or all quotations if deemed in the Town's best interest to do so. MBE/WBE firms encouraged to apply. EEO. The Select Board, or their designee, will make one contract award for the site work at the Town Hall to the responsible and responsive bidder (as determined by the Town) with the lowest price. Written quotation submissions must be all inclusive of material, labor, and equipment, except where noted. No extra charges will be allowed, any change orders must be pre-approved by both parties. The Town reserves the right to accept or reject any or all bids if it be in the Town's best interest to do so. Written proposals and prices shall stand as submitted for a period of 45 business days or until the contract is executed.

All Wage Rates will comply with those established by the Commonwealth Department of Labor and Industries M.G. L. Chapter 140, Sections 26-27G. A copy of the current prevailing wages is provided alongside this packet as a separate document on the website. Affidavit of OSHA Compliance and an insurance certificate will be required from the successful submitter.

SCOPE OF WORK

Furnish all materials and labor required to install ½" clear Polished tempered safety glass "sneeze guards", channel and supports as needed in various locations to include 4 offices at Town Hall. Channel and speaker hole covers to be satin anodized finish, with draft free speaker covers. All components shall be spelled out on an attached shop drawing with measurements which may be obtained from the Site Inspection Meeting.

SITE INSPECTION MEETING

A site inspection meeting will be held on **Thursday, November 18, 2021, at 9 a.m.** at the building at 160 Patriots Road, East Templeton, MA. The inspection will allow prospective contractors to familiarize themselves with all conditions that may affect the performance and cost of the contract and take measurements of the office areas as needed.

Contractors wanting to attend ***must*** register for the meeting on or before Wednesday, November 17, 2021, at 3:00 p.m. by contacting Holly Young, Executive Assistant at 978-894-2762. Contractors that do not register prior to 3:00 p.m. on Wednesday, November 17, 2021, will not be included in the meeting or have the opportunity to inspect the premises prior to submitting their bid.

NOTE: Failure to sign up & show up for the Site Inspection Meeting and/or become familiarized with all conditions shall not constitute a basis for subsequent contract change orders.

Questions must be received, in writing (by hand or by mail to the above address), by email (alamontagne@templetonma.gov), by Adam Lamontagne, Town Administrator, no later than 2:00 p.m. on November 22, 2021. It is the bidder's responsibility to view and account for any addendums relating to this request. These will be posted on the Town web site no later than 4:00 p.m. November 24, 2021.

The undersigned agrees that, if he/she is selected as contractor, he/she will within five days, Saturdays, Sundays and legal holidays excluded, after presentation thereof by the awarding authority, execute a contract in accordance with the terms of this general bid and furnish a Performance Bond and also a Labor and Materials or Payment bond, each of a surety company qualified to do business under the laws of the Commonwealth and satisfactory to the awarding authority and each in the sum of one hundred percent (100%) of the contract price, the premiums for which are to be paid by the general contractor and are included in the contract price.

The undersigned hereby certifies that he/she is able to furnish labor that can work in harmony with all other elements of labor employed or to be employed on the work and that he/she will comply fully with all laws and regulations applicable to awards made subject to section forty-four A.
